1837-Present

Series I includes county, state, and congressional\* election records, primarily canvasses of votes and reports of the canvassing committees, arranged chronologically. Other types of material found within the collection are returns of votes, consent of candidates, and certificates of election. The series was formed by consolidating three collections; state officers election records, county officers election records, and finally, state and county election records. The decision to join the three collections was prompted by a 1977 law (Act #42), creating a consolidated ballot which went into effect in 1978. For the first time congressional, state, and county elections appeared on the same ballot.

The election records found in Series I reflect changes in the election process. Arrangement of the collection was determined by the format of the election material as it was mandated by the Legislature. Thus changes such as the extension of the term of state officers to two years in 1870, the popular election of secretary of state and auditor of accounts in 1884, the reappearance of the office of the attorney general in 1904, and the introduction of the direct primary in 1915 all illustrate the impact of election law on the formation of election records.

Items of particular interest within this collection include correspondence relating to the consent of candidates and the first 20th century recount for a state officer, which set up the current recount process.

### Glossary

Assent of Candidate - SEE Consent of Candidate

Canvass of Votes - a detailed examination and count of votes cast in a public election  $% \left( 1\right) =\left( 1\right) +\left( 1\right) +\left($ 

Canvassing Committee - committee designated to receive and tally

the returns of votes and issue certificates. For a more complete listing of the members see 17 VSA, §2592.

Certificate of Nomination - official notice of nomination, issued by the canvassing committee

Certificate of Votes - SEE Return of Votes

Congressional Officer - a holder of the office of U.S. Senator or U.S. Representative. U.S. Senators were not popularly elected until 1914 (see U.S. Constitution, 17th Amendment).

Consent of Candidate - a form which gives the candidate's consent to printing the candidate's name on the primary ballot. Unless a Consent is filed the candidate's name shall not be printed on the ballot.

Contested Election - "The result of an election for any office, other than for the general assembly...may be contested..." 17 VSA, §2603.

County Officer - assistant judge, judge of probate, state's attorney, sheriff, high bailiff, or justice of the peace

Election by Legislature - elections held in the General Assembly for such offices as Speaker of the House, Superior or Supreme Court Judge, UVM Trustee, etc. or elections of state officers when no candidate received a popular majority.

General Election - the election held on the first Tuesday after the first Monday in November, in even numbered years. Prior to 1914, the general election was held on the first Tuesday in September in even numbered years (before 1870, elections were held annually).

Notice of Nomination - SEE Certificate of Nomination

Presidential Preference Primary - non-binding primary election, often referred to as a "beauty contest", in which the Vermont electorate can express its preference for presidential candidates of major political parties. First established in 1915, the presidential primary was abolished in 1921, then re-established in 1976.

Primary Election - any election permitting political parties to nominate candidates for office. Vermont passed a law establishing primary elections in 1915.

Return of Votes - official report from each polling place of the grand totals of all votes cast in the polling place

Recount - "if the difference between the number of votes cast for a winning candidate and the number of votes cast for a losing candidate is less than five percent of the total votes cast for all the candidates for an office, divided by the number of persons to be elected,

that losing candidate shall have the votes for that office recounted." 17 VSA, §2601. For details on procedure, see 17 VSA, §2602.

Special Election - an election which is not provided for by law to be held at stated intervals; usually held in order to fill a vacancy or to break a tie.

State Officer - governor, lt. governor, state treasurer, secretary of state, auditor of accounts, or attorney general. Secretaries of state and auditors of accounts were not popularly elected until 1884 (constitutional amendment, ratified in 1883). The office of attorney general was created in 1790, abolished in 1797, and was re-created in 1904.
