Governor Richard A. Snelling

Biography

Richard A. Snelling, a Republican, served four consecutive terms as governor, from January 1977 to January 1985. He is the longest serving Vermont executive since the early nineteenth century. governor, Snelling exercised restraint with government costs, income taxes and only moderately increased government spending. organized the Governor's Cost Control Council recommended which improvements for cost savings in state government; many of suggestions were implemented. Snelling cultivated a relationship with Quebec's Premier Rene Levesque and negotiated Hydro-Quebec energy contracts, thus reducing Vermont's dependency on Middle Eastern oil. As governor, he took a stand against the Tri-State Lottery on the grounds that it exploited the poor. He also brought new industries to Vermont and reformed the state judiciary. He worked to reform the Department of Public Safety and to reform state education. Governor Snelling's incumbancy the state celebrated the bicentennial of the Republic of Vermont and the last section of the interstate was Snelling also served number completed. on а of organizations while governor of Vermont. In 1977 he was elected to the National Governors' Association's executive committee and in 1981 he He was also appointed to the Presidential was elected chairman. Federalism Advisory Committee and worked with the White House on various federalism initiatives, but resisted some of Reagan's tax and budget proposals. In addition, he was appointed to the President's Advisory Commission on Intergovernmental Relations. Snelling also served as chairman of the Republican Governor's Association and the New England Regional Commission. He was a member of the Advisory Committee on Communication of the Republican National Committee.

Richard A. Snelling was a member of the Vermont House of Representatives from 1959-1961, 1973-1975, and 1975-1977. He was House Majority Leader from 1975-1977. He was also the Republican nominee for governor in 1966. A member of the Governor's Economic Development and Coordinating Committee during Deane Davis's administration, Snelling helped produce the report "Clean Water, Clean Air, Clean Land and Forty Thousand Jobs by 1980: Achieving the Environmental-Economic Balance." Throughout his career, Snelling has served on innumerable boards and commissions, including the Governor's Commission on the Status of Women, the Vermont Aeronautics Board, and the Greater Burlington Industrial Corporation.

Richard Snelling was born February 18, 1927 in Allentown, PA. He is married to Barbara Weil Snelling and they have four adult children. He received an A.B. from Harvard University in 1948 in government and economics. Snelling is a business executive as well as a politician. He is the founder of Shelburne Industries, Inc. a manufacturer of hardware and ski products.

In November, 1990, Richard Snelling was again elected as Vermont's governor, the first executive to return to office after leaving since Erastus Fairbanks was re-elected in 1860.

Scope and Content

The records of Governor Richard A. Snelling contain a wealth of

material on the administration of one of the most significant twentieth The basic issues of governance as well as events century governors. unique to the administration are thoroughly documented. The greatest bulk of material consists of the subject files (30 cubic feet). A wide range of topics are covered in this series including files on day care, the Nantucket Island Caper, truckers grievances, and the Abenaki. subject series includes a good deal of material on the National Governors' Association, the New England Governors' Association and the New England Regional Commission. There is considerable material on environmental issues and the energy crisis of the 1970's, including files on negotiations to buy Canadian hydro-electric power, Act 250, acid rain, nuclear power plants and weatherization programs. There is also significant material on how the governor dealt with the economic recession of the early 1980's and his various budget policies during his administration. Included is documentation of the CETA programs in The administration's encouragement of Vermont and welfare reform. and development in the state is also well-documented. business Information on the reorganization and proposed reorganization of state agencies and departments are also found in the records. The first two terms of Snelling's administration are more thoroughly documented than the later terms. There is also some scattered material dated before Snelling became governor.

The records are arranged according to the structure of Vermont state government. Each independent agency or department constitutes a series; departments or divisions attached to independent agencies or departments are subseries within the parent agency or department. There is also a series consisting of Administrative and Advisory Boards. boards and commissions within this series are not connected with any superagency or department and report directly to the governor's office. The subject series contains subject files which are unrelated to particular department concerns. Within the federal government series are various subject files relating to the federal government as well as correspondence between the governor's office and various federal agencies and departments. All series are arranged alphabetically. subseries within each series and the folders within each series and subseries are also arranged alphabetically. The table of contents lists the series and subseries. The Vermont state government organization charts were an important guide in the organization of Snelling's records; organization charts from 1977-1985 can be found in appendix A.

The Snelling administration's original filing scheme was loosely based on government structure; related files tended to be clumped together, but not consistently. Thus, order was imposed upon the records to more closely reflect government structure. The order within the folders was, however, respected and folder titles and subject headings for the most part remained the same.

The inventory is one way of accessing the Snelling records; they are also catologued on Minaret, a MARC AMC-based microcomputer software package. Minaret immeasurably broadens the accessibility to the records. The database can be searched at the State Archives for types of records (i.e. reports, press releases, photos, etc.), original Snelling file numbers, folder titles, Library of Congress subject headings (i.e. Budget, Pollution, Transportation), corporate names (Vt. Yankee Nuclear Power Plant), geographic locations, conferences, popular names of acts, and so forth. The inventory is an introduction to the records while Minaret is a much more thorough access system.

Files to be microfilmed and destroyed are grants (authorization for and approval of federal grants for state agencies and the State Office of Economic Opportunity), personnel action and employment forms, and salaries and appointments (requests for salaries for assistant attorneys general, state's and deputy state's attorneys, and sheriffs).
